Aims and Objectives.

Introduction

Iken is a small village and civil parish in the county of Suffolk. It is near the estuary of the River Alde on the North Sea coast and is located southeast of Snape and north of Sudbourne and Orford.

Iken parish is spread over a long distance following the estuary. The map in Appendix 1 illustrates how Iken follows the estuary, and a list of properties within the parish is detailed in Appendix 2. To reflect the nature of the parish, it is intended to appoint wardens to cover the length of the parish who will report to the Emergency Community Coordinator.

Aim of the Plan

- 1) To increase short-term community resilience, i.e. until such time as the responder agencies arrive.
- 2) Provide a framework of local expertise which the responder agencies can utilise as they require.

Objectives of the Plan

- a) Identify hazards and possible mitigation measures
- b) Identify resources and key contacts in the community
- c) Identify those in our community who may be vulnerable in the event of an emergency.

Role of the Parish Council

> To create and maintain a 'Community Emergency Plan' and to test it (table-top exercise) annually and implement it when appropriate

Role of the Emergency Community Co-ordinator:

- ➤ A person living locally who provides a vital link between the community and other organisations; planning for and responding to an emergency.
- ➤ The role is to:
 - Oversee the completion and maintenance of the Community Emergency Plan, liaising as necessary with the Parish Council.
 - Provide a link to the District Emergency Planning Officer
 - Call a community meeting during an emergency (if deemed necessary)
 - Provide the focal point for the community response to an emergency.
- > A deputy to be appointed during an emergency to cover illness or absence.

Role of the Area Warden

- ➤ The conduit to and from the Community coordinator.
- Find out where help/guidance/assistance may be required and what level of help is needed.
- ➤ Very often, one incident leads to another, so it MAY be possible to anticipate certain eventualities although all these may be influenced by outside forces beyond our control.
- ➤ Be visible and approachable.

Local Risk Assessment

Below is a table of likely and possible risks to Iken, details of the impact they are likely to have and steps in place to mitigate against them:

Risks	Impact on Community	What can the Community Emergency Group do to prepare?
Snow	Temporary road block	Tractor owners clear road NB 'Self help' will be entirely at the risk of the individual. See Addendum.
Surface Water Flooding	Isolation and impassable areas temporarily	Will drain away naturally
Surge Flooding	Danger to life and damage to property	Follow the Emergency Plan
Sizewell Power Station	Danger to life	Depending on the criticality, follow local news and emergency plan
Agricultural Disease	No immediate affect	Follow advice from DEFRA
Power Cut	A common occurrence that we live with	Follow advice from UKPN
Severe Storms	Stay indoors	Depending on the criticality, follow local news and emergency plan
Fire	Do not obstruct the emergency services and stay safe	Depending on the criticality, follow local news and emergency plan
Major Vehicle Accident	Temporary roadblock	Follow advice from Emergency Services

Activation triggers

The Iken Community Emergency Plan will be activated under the following circumstances:

- > Flood / Severe Weather Warning issued for the surrounding area
- ➤ Major road accident in the village
- > Forest or Heathland Fire
- ➤ Major incident at Sizewell

Steps to take in an emergency.

If the plan is activated, consider taking one or all the following steps (common sense should dictate what steps are taken at what time).

1	Call 999 if there is a clear and present risk to life or property, to ensure the Emergency
	Services are aware of the situation
2	Call 101 (police non-emergency) if there is no present risk to life or property
3	Ensure you are in no immediate danger and do not put yourself at risk
4	Contact the Community Emergency Co-Ordinator or Group and meet to discuss the
	situation
5	Contact the people on the Emergency Contact List
6	Contact anyone on the Resources List to request assistance
7	Gather emergency box and supplies
8	If Warden, pass on advice to your direct contacts

ADDENDUM - EMPLOYMENT OF FARMERS AND OTHERS FOR SNOW CLEARANCE CONTRACT

Third-Party Snow Clearing – Severe Weather Contract

Applications are invited from farmers and contractors who have any of the following plant available for hire with operator during the winters of 2019 to 2023. The contract will be held for the duration of the seasons.

Plant and Operator would be hired in times of heavy snowfall to supplement Suffolk Highways' own snow clearing operations.

- 2-wheel drive tractor and plough
- 4-wheel drive tractor and plough
- 2-wheel drive rubber tyre loading shovel
- 4-wheel drive rubber tyre loading shovel, bucket less than 2m3
- 4-wheel drive rubber tyre loading shovel, bucket greater than 2m3
- 4-wheel drive/steer rubber tyre agricultural loader/handler
- Other earth moving plant on rubber tyres
- 4-wheel drive tractor on which to mount and operate a County Council owned 2.5m wide PTO driven snow blower

Main duties

- Snow clearance within a designated area local to the base farm/depots as instructed by Suffolk Highways;
- Serving the community and keeping roads clear;
- Works undertaken in severe weather conditions during 05:00 21:00 Months October through to May

Conditions

All plant used must be in working order, insured and, where applicable, licensed to comply with the Department for Transport Regulations in force at the time of use. All staff undertaking operations are expected to be suitably trained and competent and must be able to demonstrate this.

- Required: Insurance with £5m public liability cover
- Rates of pay: typically, between £25 £45 per hour depending on type of vehicle/equipment operated and the time of day
